PARTICIPANT RELEASE FORM

I, the undersigned Participant (or the parent/guardian of undersigned Participant, if under eighteen years of age), herein acknowledge that Participant has voluntarily entered into this event, known as the "Big Air" competition to be held at the Snow Ridge Ski Resort in Turin, NY.

Participant, or his/her parent/guardian if Participant is under 18 years of age, represent & acknowledges the following:

- 1) That participation in any Event can involve serious physical injury, including, but not limited to death, to the Participant arising out of the inherent nature of the Event as much as such Event requires reasonable skill and/or good physical condition, and reasonable freedom from all physical condition limitations, health limitations, or skill limitations, that would or could interfere with the Participant's ability to safely participate in the Event.
- 2) Participant and/or his/her parent/ guardian acknowledge that the area in which the Event is held has inherent hazards, which the Participant must, of his own ability and knowledge recognize and adequately traverse or manage, which include but are not limited to snow, ice, and steep and undulating terrain, snow covered holes and other similar natural conditions as well as man-made conditions inherent to the area, devices erected for the protection and security of both the participant and the spectators, such as snow fencing, straw barrels, rope and similar boundaries all of which may, if interfered with by the Participant, or if Participant comes in contact, cause serious physical injury, including, but not limited to death.
- 3) Participant and/or his/her parent/guardian, by executing this Release, authorizes Participant to participate in the Event, confirms that the Participant is in good physical health and good physical condition, free from all physical limitations, health limitations, and medical conditions that would prevent the Participant from competing in the Event; that the Participant is not under a doctor's care (for any medical condition of any nature) and that the Participant is not currently taking any over-the-counter medication or prescriptions.
- 4) Snow Ridge personnel reserve the right to reject any Participant for any reason.
- 5) Participant and/or his/her parent/guardian states that he/she is knowledgeable with respect to the Event in which Participant is registering, has made himself/herself familiar with the area in which the event will be held, the condition of the area, all obstacles within the area, including any course, gates on any course, jumps and any conditions surrounding any area or course, and that Participant has the mental and physical skills necessary to compete in the Event.
- 6) Participant and/or his/her parent/guardian acknowledges that Snow Ridge personnel have made no representation or warranty as to any participant's physical condition, health condition, mental condition or abilities to participate in any Event.
- 7) Participant and/or his/her parent/guardian acknowledges that Snow Ridge provides no specific or non-specific insurance, health or otherwise, covering Participant's entry into competition in any Event.

8) The applicable law of New York State governs this agreement. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.

Participant or his/her parent/guardian, by executing this Release, acknowledges all of the foregoing and agrees to assume all risk both known and unknown, and assumes full responsibility for his/her participation in the Big Air Competition and does agree to comply with the stated and customary terms and conditions for participation in any event associated with the Big Air Competition.

The undersigned, for myself or for the Participant whose parent or guardian I am, on behalf of their heirs, assigns, personal representatives, and next of kin hereby indemnify, release and hold harmless the Snow Ridge Ski Resort, Inc and any of its owners, officers, directors, affiliates, officials, agents and/or employees, volunteers, sponsors, and other participants and all sponsors or donors to the Big Air Competition (collectively, the "ORGANIZERS") with respect to any and all injury, disability, death, loss or damage to persons or property, associated with or as a result of participation in any aspect of the Big Air Competition. I agree NOT to make a claim against or sue Snow Ridge for injuries or damages relating to skiing, snowboarding, and/or the use of this equipment.

I further agree to defend and indemnify "ORGANIZERS" for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to my participation in the Big Air Competition.
